### LAPD Community-Police Advisory Board Highlights:

- The new Neighborhood Watch program is available on the Wilshire Division website
- Residents should inform their Senior Lead Officer (SLO) of homelessness issues in their areas.
- LA Hop (www.la-hop.org) is making an impact with for the those who are not service-resistant, who constitute around 75% of the homeless population. 6 individuals who had been living in and around the alley east of La Brea and north of Wilshire have recently been housed.
- The Neighborhood Prosecutor serves under the City Attorney in various capacities-from general counsel to the police, to the role of prosecutor in some civil and criminal litigation. The Neighborhood Prosecutor will, when appropriate, highlight correlations between crimes which, without the background knowledge, might appear to a judge to be unrelated and to not require special attention, but which, when viewed in context, demonstrates the need for action. Sometimes the Neighborhood Prosecutor is able to secure "stayaways" for the individuals involved, preventing them from congregating in that area.
