Unfinished Business

a. <u>7-Eleven – 5279 W Olympic Blvd</u> (R. Bruce Evans - Solomon, Saltsman Jamieson)

Motion: The SSNA will write a letter of support of the 7-Eleven at 5279 W Olympic Blvd conditional on certain agreed conditions.

- Ruzanna Sahakyan (Field Consultant for 7-11 Corporate) attended with Bruce. Provisions NOT in the new CUP: Alcohol sales from 11am-11pm. No single beers, no malt liquor. However, 7-11 will comply with our requests. New ask: Want to sell certain single beers over 18oz "Craft Beers" such as Stella, Heineken, Sapporo, etc, but still no malt liquor. Letter from 7-11 submitted into the records.
- Bruce will need a letter to him and to the GWNC supporting this compromise. Want the letter before the next Land Use meeting on November 19th.

Board Member Kathy Flynn arrived at 7:48pm and quorum was established.

- Letter from 7-11 was written approx Nov 5th (no date on the actual letter)
- Hengst made the motion that The SSNA will write a letter of support of the 7-Eleven at 5279 W Olympic Blvd conditional on conditions listed in the 11/5 letter. [Note: second was not recorded]. Unanimous 3-0-0 passed.

- b. <u>Firestone Project</u> Presentation from Eric Needleman, Pouring With Heart (operator)
 - CS provided some background regarding the project and the agreed conditions with SSNA
 - Construction started in April 2019.
 - No longer 3 cuisines, only one.
 - No retail space. Could be a private room instead for meetings or birthday parties.
 - Described floorplan; not a lot changed the brewery will be on the south wall at the west end.
 - Stakeholder Adam from Sycamore asked about parking and noise, noting the permit-only parking is not in force during daytime business hours. Mr. Needleman said he should not expect much noise from the business.
 - Adam asked if new windows had been installed in the building on the east (Sycamore) side. Mr. Needleman said the'd been there the whole time but had been covered with plywood
